Guest Speaker: Vincent Gray

Please welcome Vincent Gray, recently elected Councilmember for Ward 7, as our speaker for this month's HCCA meeting. A native Washingtonian, Gray has worked in public service and advocated for the residents of DC for more than 30 years. In 1991, Gray was appointed as the Director of the Department of Human Services. He oversaw a staff of 7,000 persons and directed activities related to Public Health, Social Services, Mental Health Services and Health Care Finance.

In 1994, Gray was named the first Executive Director of Covenant House Washington, an international, faith-based organization dedicated to serving homeless and at-risk youth. He led the organization for a decade and was responsible for successful campaigns to purchase and renovate a crisis center for homeless youth and to build a new community

service center in the southeast DC community.

Councilmember Gray was overwhelmingly re-elected by Ward 7 voters to serve again as their council representative. Gray was elected as Councilmember for Ward 7 in 2004. He chaired a Special Committee on the Prevention of Youth Violence, and created the Effi Barry HIV/AIDS initiative. In 2007, he became Chairman of the Council. As Chairman, Gray was a leader in efforts to improve the Council's operations, transparency and oversight capacity, and was a champion for school reform. Vincent Gray was elected as Mayor of the District of Columbia in 2011. He served one term.

Vincent Gray has lived in SE Washington DC in the Hillcrest neighborhood of Ward 7 for more than 25 years.

A TALE OF TWO PROBLEMS

It was over two years ago that members of the Hillcrest Community Civic Association (HCCA) noticed some buckling floor boards in the southwest corner of the meeting room at the Hillcrest Recreation Center. The buckling soon became as pronounced as the waves on a small lake.

The flooring became so distorted that the corner of the room was roped off for safety reasons. The boards in the problem area were ripped out and replaced with new floor planks. It wasn't long before these new boards showed the same "wave effect." Once more the offending boards were ripped up and replaced with sheets of plywood as a temporary solution.

A major remedial construction project began in November. Front end loaders and other pieces of construction machinery showed up outside the building and began work. Soon a shallow trench began to surround the structure.

A TALE OF TWO PROBLEMS Continued...



Because of the construction, space could not be guaranteed for the HCCA annual holiday event in December. East Washington Heights made its Fountain Hall and kitchen available to the HCCA.

A new problem then arose. The expectation was that ticket sales would cover the cost of the advance down payment to the caterer for the luncheon. (Announcements were made about the coming affair beginning in the September HCCA meeting.) The caterer even extended the deadline for the deposit. However, the actual cash sales for tickets fell flat. Yvonne Burke, Chair of the Hospitality Committee, made it clear that the party was not canceled because of the change in venue, but because the deposit funds were not forthcoming from the sale of tickets.

Even though the luncheon was canceled, the HCCA held its December membership meeting at East Washington Heights Church.

Back to the Recreation Center. Ms. Gwendolyn Crump, Director of Communications for the DC Dept. of Parks and Recreation (DPR), has provided some helpful information about what is going on at the Center.

Part of the construction project is an in-depth attack upon the water seepage in both the meeting room and the gymnasium. A new drainage system is being installed. When it is completed, the plywood flooring in the meeting room will be replaced with plank flooring.

Much more is going to happen than improved drainage. We can anticipate enhancements to the building which will bring it into compliance with the 2012 "Americans with Disabilities Act." These improvements involve bathroom and kitchen renovations, resealing "identified windows with a leaking concern", and a new concrete walk for back exit doors.

The good news is that the staff at the Hillcrest Center, in coordination with program managers from DPR, will seek to keep our "Rec" Center open during the entire construction process. Some rooms will be taken out of service as they are "individually remodeled." The Communications Director went on to state that "the entire remodeling project should be wrapped up by the end of February" (or the "first of March 2017).
