Guest Speaker for February 7, 2004

Anthony A. Williams
Mayor of the District of Columbia

The Honorable Anthony A. Williams, Mayor of the District of Columbia, is coming to Hillcrest in February and will speak at the February HCCA meeting.

Mr. Robert Bobb, the new City Administrator, graciously switched places with Mayor Williams and served as our speaker for the January meeting after we were informed by the Mayor's office of an unalterable commitment that would prevent his appearance.

During his presentation, Mr. Bobb provided an update on the status of the Skyland Shopping Center project. Financing is moving forward under a 108 application and legislation will be introduced in February to support the project. The NCRC board will meet in January regarding the project, and an update will be provided in the March newsletter.

Mr. Bobb also discussed his work on the health care alliance; the restructuring of property management; youth services administration; and efforts to put more police officers in neighborhoods with involvement by all government agencies to help reduce crime and violence. There was a lively discussion focused primarily around the Skyland project, economic development east of the river, and education.

The HCCA greatly appreciates Mr. Bobb returning from an out of town trip to talk to the residents of Hillcrest about their concerns and about what's going on in local government. He proved to be an outstanding speaker, who facilitated a great discussion with the community. A parting sentiment by one resident summed it up nicely when he said that "hiring Robert Bobb was one of the best decisions the Mayor has made".

Message from the President

Dear Members of HCCA

I identified expanding the size of HCCA membership from our present level of 365 family units to 500 family units as one of the top ten items I intend to focus on during my tenure of duty as your president. The size of the civic association membership carries great weight when we are addressing issues important to the Hillcrest community to various Government officials. Personnel Changes in MPDC Affecting Our Community

Removal of Political Signs for Presidential Primary Vote

This is to encourage community action "**in the form of removal**" of political posters installed for the District's non-binding Democratic presidential primary vote that occurred on January 13, 2004. It is unfortunate that the persons who installed the signs are not equally interested in removing these eyesores. Also if you are tired of those illegal posting of signs installed on trees and lamp poles in violation of the District's poster laws that make your neighborhood look trashy, they should be removed. Signs advertising "Hub Cap Sale", "Home Buying", "Quick Loans", "Maryland Night Clubs" are still being installed in our community even with the police being on alert for these illegal acts. These types of activities, if not abated, send a message to persons interested in doing other illegal activities that it is okay to do so. The best defense to discourage the installation of illegal posting of signs in the community is to remove them as quickly as possible. There is a cost to the sponsors of illegal sign installations. Quick removal results in the sponsor not benefiting from the costs of the sign; and they normally go away. The Mayor's call center is available to assist in the removal of illegal sign postings and the issuing of fines to offenders. They can be contacted at 202-727-1000 or by use of your PC, i.e. www.dc.gov. Also, if you see signs in Maryland, please contact Mr. Paul Franklin who handles sign removals in Prince Georges County at 301-513-7311 or 301-513-7489. Mr. Franklin is very interested in the abatement of illegal sign postings and encourages that you leave a message on his answering machine, if you call and he is not there. Vincent Spaulding

Hillcrest Community Civic Association Proposed guidelines for management of meeting time

Draft: 1/10/04, to be approved by HCCA Board

The Hillcrest Community Civic Association is proud that its monthly meetings are among the best-attended of any civic association in the District of Columbia. Every monthly agenda includes reports from HCCA committees, discussion of community issues, and presentations by invited speakers. Given the desire of the Board and Members for meetings that explore issues in an efficient manner, while providing an opportunity for everyone to be heard, the following guidelines are proposed.

- Monthly meetings begin promptly at 10 am and should end by noon. The Board commits to this schedule and asks the help of Members and guests in making it happen.
- The President (or presiding officer) will announce blocks of time for consideration of topics – including committee reports, old/new business – and will allot specific time for debate after a motion is made. The written meeting agenda will continue to include timing of meeting sections.
- Each committee chair and scheduled presenter will strive to follow the prescribed time.
- Committee reports will be better coordinated in order to avoid duplication or redundancy. Chairs will note the distinction between information and action items, and will provide the Board in advance with written requests for action items. Committee chairs will request extra time, if needed, for major initiatives or important reports to the community. The Board will explore alternate ways of circulating data to the Membership outside meeting times – for example, providing crime statistics or school data through e-mail or in the HCCA newsletter.
- Guest speakers will be provided with guidelines informing them of start/end times, format of 20 minutes for presentation, and 40 minutes for questions.
- During discussion following the guest speaker's presentation, Members are encouraged to follow a one-minute rule: Questions or comments should take no more than one minute, and be directed at the topic raised by the speaker.

- In this discussion, and in the “community concerns” section at the end of each meeting, Members are encouraged to raise matters of broad interest to the Hillcrest community. Questions involving individual issues (such as a particular utilities problem or police report) should be taken up directly with the agency in question, outside of meeting time.
- HCCA's parliamentarian will be asked to write a succinct “Robert's Rules” on major points of meeting order. This will be distributed to Board and members to provide clarity about procedures. The Parliamentarian will advise the Board on points of meeting order, and will be a member of the leadership team for each monthly meeting. Nelson Smith, Secretary, HCCA

Street Sweeping Halted for Winter

Parking restrictions on posted street cleaning days throughout the District have been lifted through March 12th to coincide with the annual winter suspension of mechanical street sweeping operations by the D.C. Department of Public Works. Motorists who park along posted, alternate-side street sweeping routes will not be required to move their cars on street-sweeping days during the hiatus. City officials said no tickets will be issued for parking in violation of street-sweeping zone restrictions until the sweeping operations resume on March 15th.

Officials said the mechanical sweepers will be used on an unscheduled basis, without parking restrictions, when weather conditions permit throughout the winter. In sub-freezing temperatures, the sweepers cannot be used because they spread a thin layer of water under their rotating brushes. Officials note this could create hazardous driving conditions or impede snow removal efforts.
