Hillcrest Open Forum

At the January meeting, the HCCA held an open forum to give residents the opportunity to discuss the issues they need addressed. Several residents discussed their issues, which ranged from cell phone services to crime and trash in the neighborhood to more community outreach and

participation. Following are the issues raised and the HCCA committee to which they were assigned.

Concerns

EDUCATION/RECREATION COMMITTEE

- 1) Need more involvement from the community in the new Francis Gregory Library and its development.
- 2) Continue collaboration with the Pali-

sades Civic Association and increase participation

STREETS, TRAFFIC, TRANSPORTATION

- 1) Circulator Bus: There is a need to increase public transportation between Hillcrest and Capitol Hill. With the Pennsylvania Avenue construction and parking restrictions on the Hill, driving there is becoming increasingly difficult.
- 2) A crosswalk is needed in front the Francis Gregory Library.
- 3) Follow up on the traffic redirect that would make 27th Street two way.
- 4) Illegal turns at Branch and Alabama avenues. ANC7B is working on it.
- 5) DDOT has funds for alley repair and paving. Members should contact Alberta Paul at Alberta.paul@dc.gov.
- 6) More sidewalks are needed in Hillcrest.

PUBLIC SAFETY

- 1) Follow-up with Lt. Mark Hodge on prostitution and other crimes in the Park Drive area. Also, Park Police needs to be involved as the wooded area is Park Service's property.
- 2) Increased involvement with Neighborhood Watch (NW). Increase the level of communication on the activities with HCCA.

Did You Know You Can.....

• Get Free Computer Classes at the Library?

If you are over 55, and you live in Ward 5 or 7, you might be able to take free computer literacy classes at the Frances A. Gregory Neighborhood Library, 3660 Alabama Ave., SE, and the Woodridge Neighborhood Library, 1801 Hamlin St., NE.

The courses will cover computer basics, and include how to use a computer to manage health and finances, access government services and apply for jobs.

After 32 hours of instruction, participants will receive a free refurbished computer and may be eligible for two years of free Internet access. The program is a part-

nership between the DC Public Library, the D.C. Office of the Chief Technology Officer, and three nonprofits, Byte Back, First Time Computers, Cricket Wireless and One Economy. To register, please call (202) 529-3395 .

3) Recruit NW block captains; increase outreach within the community. Need more strengthened communication and involvement. Need to fill block captain positions.

HOUSING (NEW)

1) Create a housing committee to know what is happening with housing such as ex-offender reentry programs, group and vacant homes.

2) Need someone to take the lead on communicating to the residents that the community standards are deteriorating (trash, parking in yards, junk in yards)

ENVIRONMENTAL

1) Get support from ANC7B and Councilmember Yvette Alexander on the erosion at Algiers Park bounded by 30th and Park streets. Public alley on 30th Street is compounding the erosion because the city has not provided drainage in that area.

GOODHOPE MARKETPLACE

1) Continue the efforts to get the Marketplace owners to maintain the property,



especially the Safeway.

MEMBERSHIP

1) More community outreach to increase membership and participation. Need to find ways to meet new neighbors.

NO COMMITTEE ASSIGNED YET

1) 311 Services are not reachable by cellphone. Hillcrest needs someone to give specifics on how the system works.

2) Frequent updates on the Skyland and Penn Branch Shopping Center projects.

3) Find a way to have the city advise residents of upgrades and work planned in the neighborhood. Although certain parts of the properties are city owned, it would be great to know what is going on so that if work is needed to be done on one's property, it is done correctly and does not add damage to the property.


Committee
