BY-LAW CHANGES

These proposed by-law changes were read at the last membership meeting and will be voted on at the June meeting.

Mission and Purpose

The Hillcrest Community Civic Association (HCCA) works to enhance the quality of life and prosperity of residents, families, community organizations and institutions located within the designated geographic boundaries. HCCA fulfills its mission by engaging members in a variety of educational, social, beautification, public safety and economic activities, advancing their interest before the government and private sector and leveraging their collective influence to achieve community improvements.

Boundaries

The official boundaries of the Association are bounded by a line beginning at the intersection of 31st Street, SE and Pennsylvania Avenue, thence extending southeastward along Pennsylvania Avenue SE to the intersection of Pennsylvania Avenue, SE and the District of Columbia boundary line (at Southern Avenue, SE); thence extending southwestward along that District Line to the intersection of that line with Naylor Road, SE; from thence extending northward along Naylor Road, SE to the intersection of Naylor Road, SE with 27th Street, SE; from thence in a straight line running eastward through the park to reach the upper point of 31st Street, SE and then following 31st Street, SE northward to the original intersection of 31st Street SE and Pennsylvania Avenue, SE said boundary to include both sides of 31st Street, SE including Randle Highlands Elementary School.

Belva T. Simmons, Founder and First President of The Hillcrest Community Civic Association, passed away Friday, May 9, 2008 at Howard University Hospital.

On August 22, 1989 Belva Simmons wrote a letter to her neighbors expressing her feeling that the interest of the citizens of Hillcrest could be served by starting a neighborhood organization and that Hillcrest was the only geographically designated neighborhood in Ward 7 that did not have such an organization. Ms. Simmons held the first meeting of HCCA on Saturday, September 30, 1989 at the Lutheran Church of the Holy Comforter.

Approximately 30 residents attended this meeting and formed the basis for the current HCCA. The name Hillcrest Community Civic Association was adopted at the January 6, 1990 meeting where the group decided to meet the 1st Saturday of every month. Later Belva Simmons was elected President.

Belva once worked in the Constituent Service Office of former Councilman H.R. Crawford and served as an ANC 7B05 Commissioner.
