Cecilia Jones is this Month's Speaker

Join the HCCA board in welcoming Cecilia Jones to lead a discussion on public safety at the next HCCA meeting. Jones is the president of the Northwest Columbia Heights Community Association and the Volunteer Coordinator for the Community Criminal Justice Accountability Initiative (CCJAI).

CCJAI is a partnership between criminal justice agencies and community members. Since 2009, the CCJAI pilot program in North Columbia Heights has tracked 400 criminal cases and has submitted nearly 50 community impact statements to the courts. Jones has intervened successfully on behalf of her neighbors in situations where decisions made by the courts and city officials have not served the cause of public safety.

Community impact statements are closing the "revolving door," the chronic problem of the criminal justice system returning repeat offenders to our streets to claim their next vic-

The Hillcrest Oral History Project: A Strong DC Neighborhood

The HCCA will be involved in an oral history project that builds on the successful 20th anniversary celebration in 2009, which produced three celebratory events, several products, and was shown on Channel 16 for several months. Each captured the many elements of the HCCA's long history of accomplishments.

HCCA, which was awarded a DC Community Heritage Project grant through the Washington East Foundation, will conduct video interviews of key Hillcrest residents over the next couple of months to capture the community's strong civic engagement and its staunch pride. From these videos, key lessons will be learned.

Funds for the DC Community Heritage Project are provided by a partnership of the Humanities Council of Washington, DC, and the DC Historic Preservation Office, which supports people who want to tell stories of their neighborhoods and communities by providing information, training and financial resources. This DC Community Heritage Project has also been funded in part by the US Department of the Interior, the National Park Service Historic Preservation Fund grant funds, administered by the DC Historic Preservation Office and by the DC Commission on the Arts and Humanities.
