### What is National Night Out?

The "24<sup>th</sup> Annual National Night Out" (NNO), a unique crime/drug prevention event sponsored by the National Association of Town Watch (NATW), has been scheduled for **Tuesday, Aug. 7, 2007**. Last year's National Night Out campaign involved citizens, law enforcement agencies, civic groups, businesses, neighborhood organizations and local officials from more than 10,000 communities from all 50 states, U.S. territories, Canadian cities and military bases worldwide. In all, more than **34 million** people participated in NNO 2006.

### NATIONAL NIGHT OUT is designed to:

- Heighten crime and drug prevention awareness;
- Generate support for, and participation in, local anticrime programs;
- Strengthen neighborhood spirit and police-community partnerships; and
- Send a message to criminals letting them know that neighborhoods are organized and fighting back.

9. Developing polices for succession of HCCA officers.
10. Develop policy on how to address economic development issues.
11. Disaster preparation for our community.
12. Developing a yearly calendar of events.
