GUEST SPEAKER: DELORES BUSHONG DC Street Light Task Force

Delores Bushong, a founder of the DC Street Light Task Force, will speak on LED street lights that have been installed in some communities within the city.

The DC Street Light Task Force, composed of residents in Wards 2, 4, 5, and 8, was formed in December 2016 to inform fellow residents in DC of the harmful health impacts of the blue-rich LED street lights that the District Department of Transportation (DDOT) has installed in neighborhoods. DDOT has installed 4000 and 5000 Kelvin lights which the Medical Association says cause "disability glare" and suppress the hormone melatonin, which interrupts the circadian sleep cycle.

Having spent several hours with him and other members of the community on the 4th, it was a great shock to learn of the passing of someone so young, so vibrant, and so dedicated to improving his community.



Yantee and his wife Malika's tremendous positive impact on our community far exceeds the time they lived in Hillcrest. Yantee was a deeply positive and warm soul, a mentor for young black men, someone who was quick to laugh, and an active leader in our Hillcrest community. We all knew him because he was always the first one to volunteer, attend a Hillcrest party, or pause for a chat and a joke with a neighbor. You could always count on a new flag flying on the front porch of the Neufville home each month, continuing a favorite tradition began by his mother from his childhood home in Boston.

I will personally miss Yantee's smile as he sat across from me at the HCCA Board meetings and his willingness to volunteer to help. Yantee will be missed by all who knew him.
