WILLIAM O. HOWLAND, JR., DIRECTOR, DEPT. OF PUBLIC WORKS, TO SPEAK AT SEPTEMBER MEETING

William O. Howland, Jr, current director of the District's Department of Public Works (DPW), has more than 20 years of local government experience, primarily as a senior executive. He is approaching his first anniversary as the head of DPW. Before being confirmed as Director of DPW on November 9, 2004, Mr. Howland served as the Interim Director beginning in April 2004.

Some of his accomplishments include serving on the Downtown Congestion Task Force; reducing the District government's fleet size; developing proposals to solicit trash hauling services for the Department of Public Works; reducing the backlog of abandoned vehicles from over 1100 to less than a handful, and implementing a new residential recycling program.

STATUS OF SKYLAND SHOPPING CENTER REDEVELOPMENT

Work is still progressing towards the acquisition of land so that the redevelopment of Skyland Shopping Center can begin. The National Capital Revitalization Corporation (NCRC) has agreed to prices on several parcels of land and is currently negotiating purchase and sale agreements. Negotiations with four remaining landowners is in process. The timeline still contemplates a November 2005 acquisition completion and a March 2006 groundbreaking.

FRIENDS OF THE HILLCREST RECREATION CENTER

In December 2004 Hillcrest and the surrounding community celebrated the opening of its new Hillcrest Recreation Center, a state of the art facility that has a regulation size basketball court, computer, game, multipurpose and fitness rooms, as well as locker rooms and a kitchenette area. Outside, a walking track circles the perimeter of the facility as we pass a tot lot and playground areas, volleyball net, horseshoes, and a putting green. It has been enthusiastically used by seniors involved in the seniors program who walk along the track in the mornings. The Rec Center enthusiastically supports the NBA style basketball taking place in the gym, and the 167 children and teens enrolled in the 5 summer camps this past summer thoroughly enjoyed themselves.

It is a great facility, serving a vital role in the community, and we want to keep it that way. The **Friends of the Hillcrest Recreation Center** have formed to support the Center. We began meeting in March and have met
monthly since then. Our meetings are typically the 4th Wednesday of the month. We will fundraise to raise
funds, and work with the Department of Recreation to support it and its programs, such as getting uniforms for
the basketball teams. The boys basketball team has already won several championships, including one recently
at the Kenilworth-Parkside Recreation Center.

We will also organize and work to enhance the facility by mobilizing to get a swimming pool and to enhance the tennis courts, located near the Wellness Center, that are a part of the facility. Our first event, the first annual Family Fun Day, held Saturday, August 20, 2005 was enjoyed by neighbors and community members, including Hillcrest's two Council members, Vincent Gray and Kwame Brown, young people who use the Center, and their parents. Safeway donated the food and Poor Man's Barbecue cooked it. Our next event will be a reception, cosponsored with HCCA, to welcome DPR's new director, Kimberly Flowers. Interested in joining us? MAYOR INSTALLS A NEW BIKE LANE TO HIGHLIGHT DISTRICT BICYCLE IMPROVEMENTS

On August 19th, Mayor Williams installed a bicycle lane on "D" Street, NE to highlight bicycle-friendly improvements throughout the District. The event spotlighted DDOT's installation of 17 miles of new bicycle lanes since 2001, as part of street resurfacing projects and as stand-alone installations. DDOT has also recently published a new bicycle map, which includes all of the District's bicycle routes, lanes and trails, ratings of traffic conditions by speed and volume, details on how to navigate all the Potomac and Anacostic River bridges and instructions on loading a bicycle on a Metrobus.

HAZARDOUS WASTE AND E-CYCLING ON OCTOBER 15TH

The District's DPW will hold its bi-annual household hazardous waste and electronics recycling drop-off event on Saturday, October 15th from 9 a.m. to 3 p.m. in the Carter Barron Amphitheatre parking lot at 16th and Kennedy Streets, NW. These services are free and open to all District residents. Household hazards include old cleaning and gardening chemicals, pesticides and poisons, acids, varnish, oil based paints, solvents, aerosols, wood preservatives, spent batteries of all kinds, roofing tar, chemistry sets, automotive fluids, and even asbestos floor tiles.

DPW will also have an electronics recycling station to receive end-of-life televisions, office and audio equipment, computers, computer parts, and accessories. All computer monitors and t.v. screens must be intact, not cracked, punctured, or shattered.
