## Message from the President

Dear Neighbor,

September 12, 2006 is the date for the Primary vote in the District of Columbia. At this time we will be voting for candidates to run in the General Election for Mayor of the City, Chairperson of the City Council, and for a Councilmember-At-Large position. The foregoing elected positions impact directly upon the needs and concerns of our community. There are other elected positions that will be decided for candidates for City Council in other parts of the City. Irrespective of who you decide to vote for, it is important that you exercise your right to vote. During an election year the newspapers, television, and radio, are filled with candidates, their issues, etc. There are so many viewpoints to consider and issues to keep in mind that it can become frustrating to the point of not caring. It is during this time that we need to stress the importance of voting. Voting is a right, a privilege, and an American duty to be a part of the election of our government. John Jay stressed the importance of voting best when he said "Americans are the first people whom Heaven has favored with an opportunity of deliberating upon and choosing the forms of government under which they should live". Often, people don't vote because they think their vote doesn't count. Just remember that one vote in 1920 gave women the right to vote; Alaska gained statehood in 1867 by one vote; and President Andrew Johnson was saved from impeachment by just one vote in the U.S. Senate in 1868. Don't forget to vote on September 12<sup>th</sup>! And I encourage the members of our civic association to support political candidates who come out in support of strong pro-active actions to address the needs and concerns of our community. These concerns include: better schools, health care, public safety, economic development in East Washington, city cleanliness, and, in general, programs and initiatives to provide a better place to live, work, and raise a family.

## NCRC HOSTS A SKYLAND PLANNING KICK-OFF MEETING

Nearly 100 Hillcrest residents came out Saturday, August 19<sup>th</sup> to East Washington Heights Baptist Church to participate in the National Capital Revitalization Corporation's (NCRC) Skyland Planning Kick-Off meeting. NCRC, along with its development team from Leo A. Daly, the master planners of the redevelopment, introduced housing as a new development component of the Skyland project. With housing now part of the development concept, the group presented a slideshow which featured local and national examples of "town center" mixed-use developments. Meeting attendees also participated in group discussions to determine the kinds of planning options for the site. NCRC is preparing for a planning charette this fall that will detail design options that include a sit-down restaurant, an anchor tenant, and a mix of retail options.
