Lara Levison is a volunteer with the DC Chapter of the Sierra Club, serving as chair of the group's Clean Energy Committee and as a board member. The Sierra Club is the nation's oldest and largest environmental advocacy organization. In her day job, Lara is the government relations director for Oceana, an ocean conservation organization. Lara previously worked for several other NGOs, in the Obama Administration, and for Speaker Nancy Pelosi. Lara will discuss how a broad coalition of DC groups concerned about climate change and its impacts on our city pushed for legislation that became the Clean Energy DC Omnibus Amendment Act (B22-0904), which passed the DC Council in December. She'll also describe the provisions of the bill and how they will benefit our city.
