### **National Cherry Blossom Festival Community Planting In Hillcrest?**

The National Cherry Blossom Festival is committed to expanding the Tidal Basin's beauty and celebration to the neighborhoods and communities in the Washington area. Next spring the Festival will grant a trio of cherry trees to a community group in each of the District's eight wards. D.C. Greenworks, a community-based urban forestry organization, will work with each group to ensure the trees are properly planted and the community members are trained to best care for these ornamental trees.

Grantees will be selected on the basis of:

- The group's interest in planting and adopting cherry trees (trees must be planted on public land)
- The group's ability and commitment to take care of the trees
- The appropriateness of the group's proposed planting site

The size of the trees your group will receive will guarantee an instant impact on your neighborhood's landscape, but this also means the trees will be big and heavy. A group of seven (7) adults will be required to properly plant and care for your three new cherry trees.

The election procedure, as defined in the HCCA by-laws, was used to fill the eighteen available positions. The procedure calls for the selection of a nominating committee which is responsible for canvassing the membership and producing a slate of nominees for the positions. The slate is presented to the membership the meeting prior to the election. The by-laws allow the nominating committee the option of selecting more than one candidate per position. Additional candidates for any position may be nominated from the floor before the start of voting.

The term for the newly elected officers and committee chairs is two years and begins January 2005. Members of the Nominating committee were Dorothy Anthony, Marvin Bowser, Kenneth Burke, Ken Davis, and Faith Lyles.

### **Another Hillcrest-Palisades Neighbors Through Art Success!**

“Neighbors Through Art” did it again on Sunday, October 24th from 2 to 5 p.m., with a program of artistic expression on the theme of integration and civil rights. Residents of both neighborhoods coordinated for almost a year on this program which featured visual, literary, and musical artists as well as a panel, that gave their impressions of the impact of the Brown v. Board of Education decision of 1954 and other significant civil rights milestones.

Originally founded by Miles Steele (Hillcrest) and Alice Stewart (Palisades), this collaborative effort is the third one for this group and there is room for more involvement by residents of both neighborhoods in this exciting and interesting venture that brings people together from two different corners of the city. ### **Skyland is On the Move!**

On November 13, 2004 about 100 people attended the Skyland Town Hall meeting at the Winston Education Center to discuss retail priorities and design preferences for the new Skyland Shopping Center. Most of the attendees lived within a half mile of the shopping center and nearly half stated that this was the first meeting on Skyland that they had attended. The well-attended event was the first of its kind since the National Capital Revitalization Corporation (NCRC) sold downtown property in August. It is the proceeds of that sale that will be used to acquire the property for the new Skyland Shopping Center.

NCRC Interim Chief Executive Anthony Freeman got the day’s events started by greeting the attendees and laying out the purpose of the meeting. The participant guide provided by NCRC highlighted the economics of Skyland today. For example, Skyland businesses currently generate approximately \$150 in sales per square foot, compared to \$325 per square foot generated by businesses located at the Good Hope Marketplace, which opened in 1997. NCRC commissioned a study in 2003 that revealed that East of the River residents have the retail purchasing power of approximately \$574 million but more than \$400 million (70%) of that is being spent outside of their community. This reflects a large untapped market and missed opportunities for residents and businesses.

Using handheld keypads, attendees responded to survey questions intended to elicit responses about preferred uses. The uses most desired by the attendees included a sit down restaurant, coffee shop and clothing store. It was noted that while most of the attendees lived within a half mile of Skyland, the majority responded that they rarely shop there on a regular basis.

Vincent Spaulding, President of the Hillcrest Community Civic Association, presented a synopsis of the community's efforts over the last 15 years to see the center improved. Lead developers Gary Rappaport (The Rappaport Companies) and Merrick Malone (Harrison Malone Development) presented a preliminary site plan, which showed a proposed Target and Shoppers Food Warehouse, space for up to 24 additional stores and 1,100 parking spaces. To date, more than 30 plans for Skyland have been discussed and analyzed. The proposed configuration would be a welcomed improvement over the current center which has many older structures with visible signs of stress from years of deferred maintenance with gaps between buildings, poor lighting, and parking areas in poor condition which helps attract illicit activity.
