PARK APPRECIATION DAY

To foster appreciation for the park, the Environmental Committee of HCCA sponsored hikes in June and October. The events, attended by a combined 50 – 60 people, were enriching and rewarding experiences for those participating. We certainly hope you will join us on our next outing. FALL LEAF COLLECTION

The Dept of Public Works (DPW) started collecting fallen leaves from residences on October 31, 2005 and will continue to do so through January 7, 2006. Leaves will be collected in this area during the last period from December 12th to 24th (rake leaves out by December 11th). There are three (3) options for collection: 1) rake loose leaves into piles in your curbside tree box space so that they can be collected with a vacuum truck; 2) place bagged leaves in your curbside tree box space and they will be collected by a packer truck; or 3) if you have alley trash collection, place bagged leaves where you place your trash and they will be collected with the trash. Leaves may also be disposed of at the Ft. Totten Trash Transfer Station , 4900 Bates Rd. NE. Ft. Totten is open to residents Monday to Friday from 1 p.m. to 5 p.m. and Saturday from 8 a.m. to 3 p.m. For more details, call 202 576-6803.
