### ***HCCA Mourns the Passing of the Honorable Marion S. Barry, our Former Hillcrest Neighbor and Friend***

The Hillcrest Community Civic Association joined our neighbor and current Mayor, Vince C. Gray, the residents of Washington, DC and the Nation in expressing our deep sadness over the loss of Mayor Barry. We recall him as a neighbor who lived at 3607 Suitland Road, along with his wife, Effi and son, Christopher. Upon moving to Hillcrest, he began the process of installing street lights on Suitland Road for safety and championed other changes to improve our community. Mayor Barry lived in this home for 14 years when he served his first three terms as Mayor.

A topnotch political strategist, Mayor Barry served 16 years as Mayor of Washington, DC, 15 years on the City Council and president of the city's former Board of Education. He was considered the most influential and savvy local politician of his generation. Mayor Barry easily worked and mingled with those at the highest levels of political and economic power, yet never lost the common touch. He created opportunities to uplift citizens of the District, creating summer jobs programs for youth, senior citizen initiatives, and home-buying assistance programs. Many residents of Hillcrest and across the metro-area owe their middle to upper class status to the management positions created during the Barry administration.

Referring to his legacy, Mayor Barry recalled his accomplishments with the construction of 23 million square feet of office and retail space in downtown DC, new housing across the city, and the former MCI Center. He oversaw the development of several government office buildings in the city.

HCCA deeply mourns his loss and extends our heartfelt condolences to his family, colleagues on the D.C. City Council, constituents, and friends.

## **Washington Post Prints Letter of Hillcrest Resident, Kathy Chamberlain:**

None of the District's mayoral candidates seemed interested in important transportation issues facing the city, particularly those neighborhoods underserved by public transportation and involving pedestrian safety.

In my neighborhood of Hillcrest, where the bus is the most common form of public transportation, why must we walk in the street to the bus stops? Hillcrest, which includes about one square mile, has 22 blocks with no sidewalks and at least 10 dead-end or incomplete sidewalks. (My neighbor and I surveyed.) Yet the candidates seemed unable or unwilling to make the connection between pedestrian safety and the need for sidewalks, including in residential neighborhoods, so that residents of all ages can walk safely to schools, bus stops, shops, etc.

Perhaps it is because sidewalk installation is not popular with some residents who see their neighborhood as close-in suburbia and want to preserve their lawns. It's too late now, but it would have been refreshing to see the candidates take a stand on the need to facilitate the most basic form of transportation — walking — even at the risk of losing a few votes. ## **Library of Congress Shows Hillcrest in Digitized Historic 1919 Washington DC Realty Ownership Maps**

Thanks to Katherine Tobin, a Hillcrest resident, for sharing the following link to 1919 real property maps of various sections of Washington DC. Ms. Tobin posted the link provided by the Library of Congress on the Hillcrest List serve. It is a fascinating piece of history to see who may have owned the land in 1919 where your property now sits. The Hillcrest maps also show the Non Such Plantation and the land owned by the United States Realty Company which was owned by Andrew T. Randle who developed the "Little" White House on Pennsylvania Avenue SE, the Fire Station next to it and maybe the elementary school named after him. ## **November 4th Election Voter Turnout was relatively low in Precinct 110 at Thirty-Eight Percent**

According to the D.C. Board of Elections and Ethics: 149,811 voters out of 461,325 cast votes in the November 4th election. Ward 7 voted at 26% with 15,348 voters. Precinct 110 at St. Timothy's had 1,642 voters out of 4,343 voters, which reflects 37.81% of voters registered for Precinct 110. Of the votes from Precinct 110, Bowser captured 67.66% for Mayor, while Catania garnered 16.50%. For Council Chairman, Phil Mendelson captured 1,419 votes or 86% from Precinct 110. The other breakdowns from the City voters overall are: Ward 1: 58,470; Ward 2: 14,199; Ward 3: 22,922; Ward 4: 23,381; Ward 5: 19,532; Ward 6: 24,367; Ward 7: 15,348; and Ward 8: 11,035.
