Guest Speakers for March 6, 2004

**Ray Browne, U.S. Representative for the District of Columbia,
Paul Strauss, U.S. Senator for the District of Columbia,
and a representative from DC Vote**

Ray Browne is a native of the District of Columbia who is committed to obtaining self-determination for the citizens of the District of Columbia. He grew up in the Trinidad section of the City, attended Wheatley Elementary School and has a long and impressive record of success in both the private and public sectors. In public life, Browne has been an ANC Commissioner, a member of the Neighborhood Planning Council, a Mediator for the Washington Superior Court and a leader in the Democratic Party. He has been a consistent and vigorous voice for the right to vote in the District of Columbia and for the right to voting representation in the U.S. Congress.

As a member of the DC Major's Commission on Alcoholism and of The Drug Strategy Team, Browne has fought for programs to assist substance abusers. And, in the late 1980s, when AIDS was considered a disease for drug addicts and homosexuals, Browne fought with his own insurance industry to obtain coverage for the dreaded disease. Despite major opposition from his peers, Browne was successful in initiating the concept of a health insurance pool for those who are uninsurable. Browne also was a strong leader in the establishment of mandated alcohol, drug and mental health benefits for residents of the District.

Paul Strauss is currently serving his second term in the 108th Congress as our D.C. Shadow Senator. As a non-voting representative to the U.S. Senate, Strauss lobbies the U.S. Senate and the U.S. House of Representatives on behalf of the citizens of the District of Columbia in their attempt to gain full Federal representation, self-determination, and eventually admittance to the union as the nation's 51st state. The Senator also works closely with the non-voting U.S. Congressional Delegate, the Office of the Mayor, and the D.C. City Council members to advance the interests of local residents on Federal issues.

Prior to first being elected Senator in 1996, Paul served in several locally elected government positions. His elected positions include at-large member of the D.C. Democratic State Committee, Chairperson of the Democratic Party's D.C. Statehood Committee, Chairperson of Advisory Neighborhood Committee (ANC) 3E, and Chairperson of Neighborhood Planning Council #3. Paul was first elected the ANC in 1986. In 1987, he became the youngest ANC chairperson and served as an ANC Commissioner until 1996.

Important Hearing on Skyland Redevelopment March 23rd PLEASE ATTEND

The wheels of government are moving toward redevelopment of the Skyland Shopping Center at last! Please show your support by attending a public hearing on March 23rd, 7:00 - 9:00 pm, at the Lutheran Church of the Holy Comforter, 3319 Alabama Ave, SE. The Office of the Deputy Mayor for Planning and Economic Development and the Department of Housing and Community Development (DHCD) will jointly hold a public hearing on the Section 108 loan guarantee application to get \$27.97 million so the National Capital Revitalization Corporation (NCRC) can proceed with land assembly and preparation on the Skyland project. It is important that residents of Hillcrest and nearby neighborhoods turn out in large numbers for this hearing. The official notice of the hearing, including information on how to testify, will be available at the March 6th HCCA meeting, or visit www.anc7b.org and click "Skyland Public Hearing".

Highlights from Feb. 7th HCCA Meeting

- Capt. Henry and Inspector Maupin reported progress on the auto-theft problem, , saying that many arrests had been made in the past week.
- Membership chair Gloria Logan announced a new drive to boost Association membership to 500, and asked Members to give application forms to their neighbors
- Environment Chair Phil Hammond circulated a petition asking WASA to provide testing kits for lead in drinking water.
- Mayor Williams addressed four areas of critical emphasis: Public safety, health, education, and full democracy for DC.
- The Mayor reaffirmed support for the Skyland project as a "Number 1 priority" that will require "the threat if not the exercise of eminent domain." He is also bringing in Vartan Gregorian (former head of the NY Public Library) to advise on improvements to DC's library system.

Ideas for the Spring Shade Garden

Spring is just around the corner. It's time to start quaking up that garden. Many Hillcrest homes enjoy quite a bit of shade which does present gardening challenges. Here are some ideas to brighten bare areas before the hostas emerge completely and the soil warms up enough to plant the summer impatiens. Follow the design rule of combining the three plant forms - Tall and Spiky in the back, Round and Full plant shapes in the middle and Cascading forms to fill out the front. Many of these plants will continue to thrive through the summer adding texture and color to your hostas and impatiens.

Foxglove - This must-have plant for the shade garden produces statuesque spires of rose-pink bell shaped blooms. You can also find cultivars that bloom peach, white or yellow. Bi-annual. Plant form - Tall and Spiky.

Solomon's Seal - Candy cane striped green and white leaves accent the long stems with white flowers in mid-spring. Foliage persists through the summer. Perennial. Plant form - Tall and Spiky.

Heuchera (Coral Bells)'Plum Pudding' - The glossy, claret red ruffled leaves accented with silver marbling provide a dramatic background for the sprays of delicate pink flowers. Best set against light foliage plants such as Japanese Painted Fern, gray leafed hostas and impatiens. Perennial. Plant form - Round and Full

Bellis perennis (English Daisy) - This cheerful flower provides early spring color in the garden, producing masses of pompon-like blooms over mounded rosettes of green foliage. Perennial. Plant form - Round and Full.

Phlox stolonifera (Creeping Phlox) 'Pink Ridge' - This lovely true pink phlox makes an excellent groundcover in the native shade garden. Forms a dense carpet of delicate foliage with flowers that cover the plant in spring. Perennial. Plant form - Cascading.

Lamium 'Orchid Frost' - This low growing groundcover has blue-green foliage with silver accents, which makes it perfect for adding both sparkle and texture to a shade garden. Brilliant pink flowers appear in late spring through early summer. Plant form - Cascading.

Japanese Painted Fern - Highlight shady areas with the silvery sheen of Japanese Painted Fern's foliage. It is effective both as an accent plant in a container or in large drifts along a shady path. Hardy to zone 5. Perennial. Plant form - Round and Full.
