Dinkins, a Hillcrest resident, has worked in the Office of Pesticide Programs' Communication Services Branch since 1992, and is currently managing various public awareness campaigns and outreach projects that educate the public on preventing pesticide poisonings, pest management, and alternatives to chemical pest control.

She is currently representing the EPA on the National Poison Prevention Week Council and has been a council member for 12 years. She has served as Council Chair for two years. Before working for the EPA, Dinkins worked in account management for Young and Rubicam Advertising, and Abramson Associates Advertising. She has a bachelor of arts degree in journalism and public relations from Howard University.

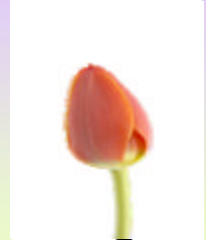
Message from the President

Did You Know You Can.....

- **Visit 311.dc.gov for Easy Online Access to City Services?**

Most of us know to call 311 for non-emergency calls but most of us don't realize you can now go online for 311 requests. The DC government recently provided online access to city services through the Service Request Center at 311.dc.gov (no www before it.) From trash pick-up to poster removal to traffic signals, the Service Request Center makes it easy to submit requests online. You'll receive a tracking number, allowing you to check the status of your request.

- **Learn How to Create a BackYard Habitat from the NWF?**

 The latter should be helpful for neighborhood watch issues—for example when you want to notify a neighbor about something going on at their home but you can't remember their name.
 About 30 residents opted out of being listed, so the booklet does not include all members. We hope that the unlisted members will consider being listed when the directory is reprinted, probably six to 12 months from now.
 If you joined HCCA after January 2010, you may not be listed. We'll include you in the next version. The cost of the directory is \$8. If you'd like one but can't make the meet-

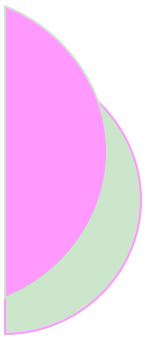
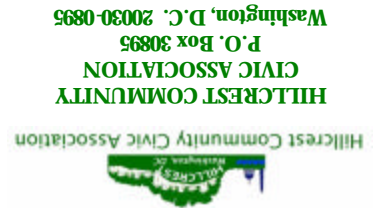
